Report of the Chairman on result of the meeting of the Unsecured Creditors of Aarneel Technocrafts Private Limited

The said meeting was attended either personally/ through authorized representative through Video Conferencing by 19 Unsecured Creditors of the Applicant Company 1 having total outstanding balance of Rs. 38,30,44,430 (Rupees Thirty Eight Crores Thirty Lakhs Forty Four Thousand Four Hundred and Thirty), on 31st December, 2020, representing 75.94% of the total value of Unsecured Creditors of the Applicant Company 1.


